The user shall indemnify, defend and hold harmless the municipality and its officials, employees and agents from and against any and all liabilities, judgments, settlements, losses, costs or charges (including attorney fees) incurred by the municipality and/or any of its officials, employees or agents as a result of any claim, demand, action or suit relating to any bodily injury (including death), loss of property, damage caused by, arising out of, related to, or associated with the use of city facilities pursuant to this agreement.

THESE CITY FACILITIES CLOSE AT 10:00 P.M., UNLESS OTHERWISE PRE-APPROVED BY THE CITY IN WRITING

NO GLASS CONTAINERS ALLOWED ON CITY PROPERTIES

GROUPS OF 3 OR MORE HAVING ALCOHOL MUST ACQUIRE A \$5.00 LIQUOR PERMIT FROM CITY HALL. PERMIT IS GOOD ONLY FOR DATE AND TIME LISTED.

NO LITTERING – PLACE ALL TRASH IN, OR BAGGED BESIDE, GARBAGE CANS

NO AMPLIFIED MUSIC, SOUNDS OR VOICES AFTER 10:00 P.M. WITHOUT PRIOR APPROVAL BY THE CITY

PETS MUST BE ON A LEASH

NO FIREARMS OR WEAPONS OF ANY KIND ALLOWED

NO CUTTING TREES, BREAKING LIMBS, NO HAMMERING NAILS INTO TREES

PARK SPEED LIMIT IS 15 MPH

NO ALTERATIONS TO CITY PROPERTY OR EQUIPMENT

NO HITTING, THROWING OF BALLS AGAINST FENCES OR BUILDINGS

NO PERSON/GROUP SHALL UTILIZE ANY PORTION OF CITY PROPERTY FOR REVENUE PRODUCING ACTIVITIES OR SOLICIT FUNDS FOR ANY BUSINESS, OR FOR ANY ACTIVITY INVOLVING PUBLIC ASSEMBLY, EXHIBITS, CONCERTS OR ENTERTAINMENT WITHOUT FIRST OBTAINING A PERMIT ISSUED BY THE CITY AND COMPLYING WITH ALL APPLICABLE CITY, COUNTY, AND STATE REQUIREMENTS.

RESERVATIONS FOR THE USE OF CITY PARKS SHALL BE ISSUED ON A FIRST COME, FIRST SERVED BASIS ONLY, AS APPROVED BY THE AUTHORIZED CITY OFFICIALS. CITY RESERVES THE RIGHTS TO CANCEL ANY PERMIT OR APPROVAL GRANTED TO ANY PARTY, AT ANY TIME, WITHOUT ANY REASON, TO PROTECT THE CITY'S INTEREST.

BALLFIELD LIGHTS MUST BE OFF BY 10:00 P.M.

FIRES ALLOWED ONLY IN DESIGNATED AREAS, WITH PRIOR APPROVAL FROM THE CITY
