ORDINANCE NO. 834 – AN ORDINANCE OF THE CITY OF GLOBE, ARIZONA, RELATING TO THE PRIVILEGE LICENSE TAX; AMENDING THE CITY CODE BY INCREASING THE GENERAL RATE OF TAXATION BY ONE POINT ONE SEVEN PERCENT; RESULTING IN A CHANGE FROM TWO PERCENT (2%) TO THREE AND SEVENTEEN ONE-HUNDREDTHS PERCENT (3.17%); PROVIDING PENALTIES FOR THE VIOLATION THEREOF; PROVIDING FOR SEVERABILITY; DESIGNATING AN EFFECTIVE DATE; DESIGNATING AN ENDING DATE AND MAKING PROVISION FOR EXISTING CONTRACTS

ORDINANCE NO. 833 – AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF GLOBE, COUNTY OF GILA, STATE OF ARIZONA LEVYING UPON THE ASSESSED VALUATION OF THE PROPERTY WITHIN THE CITY OF GLOBE, SUBJECT TO TAXATION A CERTAIN SUM UPON EACH ONE HUNDRED DOLLARS (\$100.00) OF VALUATION SUFFICIENT TO RAISE THE AMOUNT ESTIMATED TO BE REQUIRED IN THE ANNUAL BUDGET, LESS THE AMOUNT ESTIMATED TO BE RECEIVED FROM OTHER SOURCES OF REVENUE; PROVIDING FUNDS FOR GENERAL MUNICIPAL EXPENSES FOR THE FISCAL YEAR ENDING THE 30th DAY OF JUNE, 2017.


