REQUESTER(S) MUST BE 18 YEARS OF AGE OR OLDER.

REQUESTS FOR THE USE OF CITY FACILITIES SHALL BE GRANTED ON A FIRST COME, FIRST SERVE BASIS AND MUST BE REQUESTED AT LEAST **24** HOURS IN ADVANCE. REQUESTS MAY BE DENIED OR CANCELLED BY THE CITY OF GLOBE AT ANY TIME.

**NO EQUIPMENT, BOUNCE HOUSES, ELECTRICAL CORDS, ETC, ALLOWED IN/ON ROADWAYS, SIDEWALKS, SPORTS FIELDS OR OVER FENCING/BARRICADES. BOUNCE HOUSES ARE ALLOWED IN PARK AREA ONLY.**

PARTIES CONSUMING ALCOHOL MUST ACQUIRE A LIQUOR PERMIT. PERMIT IS GOOD ONLY FOR DATE AND TIMES LISTED. NO GLASS CONTAINERS ALLOWED ON CITY PROPERTIES.

ALL CITY PARKS AND SPORTS FIELDS CLOSE AT **10:00 P.M.**

FIELD LIGHTS MUST BE OFF BY **10:00 P.M.**

PETS MUST BE ON A LEASH.

NO FIREARMS OR WEAPONS OF ANY KIND ALLOWED.

PARK SPEED LIMIT IS 15 MPH.

NO LITTERING. PLACE ALL TRASH IN, OR BAGGED BESIDE, GARBAGE CANS.

FIRES ALLOWED ONLY IN DESIGNATED AREAS.

MOTORIZED VEHICLES MAY NOT BE DRIVEN ON OR PARKED UPON ANY OFF-ROAD AREAS.

NO ALTERATIONS/DAMAGES TO CITY PROPERTY OR EQUIPMENT. INDIVIDUAL(S)/GROUP(S) WILL BE HELD LIABLE FOR ANY DAMAGES CAUSED TO CITY FACILITIES, PROPERTY OR EQUIPMENT.

SPECIAL EVENT PERMITS MAY BE REQUIRED FOR REVENUE PRODUCING ACTIVITIES OR ACTIVITIES INVOLVING PUBLIC ASSEMBLY, EXHIBITS, CONCERTS OR ENTERTAINMENT. SPECIAL EVENT PERMITS ARE ISSUED BY THE CITY OF GLOBE.

THE CITY OF GLOBE WILL NOT BE HELD LIABLE FOR ANY INJURIES SUSTAINED DURING ANY ACTIVITY HELD ON CITY PROPERTY.
